

The Pennsylvania Citizen Law Enforcement Advisory and Review (CLEAR) Commission Quarterly Meeting Minutes

Tuesday, March 19, 2024, at 11:00 a.m.

(In person at Pennsylvania Commission on Crime & Delinquency and Virtually *via* Microsoft Teams Platform)

At 10:30 a.m. Administrative Session

Christa Caceres, Commission Chairwoman, began an Administrative Session which included discussion of various administrative items and a review of the Commission's meeting Agenda.

At 11:03 a.m. Public Meeting Started and Recording Began

Chairwoman opened the meeting stating the date, time and made the audience aware that the meeting was being recorded.

At 11:04 a.m. Introduction of, and Roll Call by, Acting Secretary Commissioner Amy Zapp

Acting Secretary Commissioner Amy Zapp read the names of all Commission voting members aloud and those present whether in person or virtually responded by announcing their presence. All 10 voting members (two had some technical difficulties and could not unmute to be heard when their names were called but could be seen as a participant, Commissioner Benjamin Lerner, and Commissioner Leon Ford) were in attendance and a quorum of the Commission's voting members was met. At 11:06 a.m. Introduction of State Inspector General Lucas M. Miller

General Miller addressed the Commission with brief remarks.

At 11:10 a.m. Opening Remarks by Commission Chairwoman and Introduction OSIG Administrative Staff and Ex-Officio Members

After Chairwoman Caceres gave her prepared opening remarks which included some personal background, she expressed how she envisions and hopes the Commission will move forward and how excited she is to get started on the work of the Commission.

11:20 a.m. Introduction of Commission Members

Chairwoman Caceres introduced each voting member of the Commission, and each voting member gave brief remarks. All 9 members gave remarks.

11:30 a.m. Appointment of Commissioner Amy Zapp as Commission Secretary.

Chairwoman Caceres asked for a motion to accept the appointment of Acting Secretary Commissioner Amy Zapp to permanently appoint her as the Commission Secretary. Vice Chair Sonenshein moved to vote, Commissioner Wilson seconded the Motion. With no questions or discussion and a unanimous vote of all Commissioners, the appointment of Commissioner Amy Zapp as Secretary passed unanimously.

11:35 a.m. Motion to Adopt – Bylaws of the Pennsylvania Citizen Law Enforcement Advisory and Review Committee.

Chairwoman Caceres stated that the bylaws outline the rules and regulations that govern our Commission and guide our individual and collective responsibilities that will ensure our success.
